K Live on Citizen TV broadcast a televised town hall on August 20, 2025 from the Kenya School of Government (KSG), Lower Kabete Campus. hosted by the State Department for Public Service and Human Capital Development, KSG, and Huduma Kenya Secretariat, the event brought together leaders and citizens to reflect on the transformation of the public service – celebrating milestones, addressing challenges, and charting the road ahead.

Cabinet Secretary for Public

Service, Human Capital Special Development and Programmes, Hon. Geoffrey Kiringa Ruku, noted that while the public service has already significant undergone transformation, there are bold plans to take the reforms even further.

"We are building a public service that is firm, progressive and responsive- one that delivers swift and reliable services to the people of Kenya, who rightfully expect prompt rather responses than unnecessary delays," he said, adding, "To realize this vision, we will enhance the training of public servants in customer

service excellence while equipping them with advanced competencies in emerging technologies. They should be strategically prepared to navigate and lead in the demands of an ever-evolving global landscape."

With regard to ongoing public service reforms, the emphasized that recruitment into government is strictly merit-based only ensuring qualified, competent, and committed individuals serve the nation. "These reforms will establish a public service that is modern, and fully empowered to deliver on the promises o f national development," he added.

Public Service and Human Capital Development Principal Secretary, Dr. Jane Kere Imbunya, highlighted the progress made in recent years. "The public service has made great strides, from automation of the payroll to broader government reorganization. As we embrace AI and digital tools, we remain steadfast to upholding ethical codes and standards, with a strong data protection unit

guiding this transition. Let us continue building a public service that is transparent, inclusive and focused on delivering for all Kenyans."

Kenya School of Government Director General, Prof. Nura Mohamed, highlighted the School's strategies, projects and innovations that continue to strengthen leadership and build capacity across the public service.

"We are preparing for futuristic leadership through establishment of the Regional Center of Competence for Digital and AI Skilling for the Public Sector. KSG plans to integrate Artificial Intelligence that will bring services right at the people's doorsteps. In addition, we are collaborating with digitally advanced countries such as Estonia and India to build the capacity of our faculty, who will in turn transfer this knowledge to public servants." He said

The Director General further underscored the centrality of ethical leadership in shaping a credible and citizen-focused public service. He announced that KSG, in collaboration with other key institutions, has developed a flagship program on Governance, Ethics, Integrity, and Culture Change- an initiative that is designed to anchor a shift in public service culture, with its anticipated impact as the creation of a service that not only meets the needs of citizens but also earns their trust through values-driven leadership.

When asked about the quality of service at the Huduma Centres, Huduma Kenya Secretariat CEO, CPA Ben Kai Chilumo, gave an assurance that the Secretariat is implementing the aspirations of Kenyans by offering prompt service. matters inclusivity, the CEO outlined strategies that are ensuring marginalized communities and those with special needs have access to government services. "Inclusivity isn't just a principle of governance, it is our practice." He stated.

Other issues raised were the requirements of Chapter Six of the Constitution of Kenya on

Leadership and Integrity, particularly the lengthy time taken to process official documents. This would be up scaled to the Ethics and Anti-Corruption Commission (EACC), which is mandated to process such documents.

Digital transformation has

enabled seamless work, making it possible to deliver from virtually anywhere. However, it was clarified that certain government services remain essentially human centered and require direct interaction, underscoring the need for every officer to continuously enhance

the quality of service delivery.

The Call to Action from Cabinet Secretary Ruku was for all Ministries, Departments, and State Corporations onboard their services onto Huduma platforms in order to enhance efficiency and improve service delivery to citizens.

he Kenya School of Government (KSG) Director General, Prof. Nura Mohamed, highlighted the pivotal role of digital transformation in promoting effective governance during his keynote at the Digitally Fit Awards - Person of the Year, CEOs and Experts Edition, where he was also recognized for his leadership in advancing digital innovation in public service.

Prof. Mohamed stressed the urgency of embracing technology in the public sector, describing digital transformation as "the new oxygen of progress." He emphasized that technology alone does not drive change, but people do.

In his remarks, he commended the Awards for spotlighting individuals and institutions that are not just talking about change but driving it. "When we honor champions of digital transformation, we do more than hand over trophies. We ignite a culture, a movement, and a future."

Reflecting on the timeliness of the Awards' theme, "Champions of Digital Transformation," Prof. Mohamed noted that the world is moving at digital speed and that "standing still is not an option." He highlighted the rapid technological changes shaping governance, ranging from artificial intelligence and blockchain to fintech and GovTech. Underscoring KSG's role in journey, the Director General outlined how the School equips leaders, managers, and public servants with the skills to lead in a digital world. He cited an e-learning platform reaching thousands of public servants across the country, AI and datadriven governance programs enabling faster, evidence-based decisions, and digital literacy training for senior officials and front-line staff, ensuring inclusivity in the impactful journey, as some of the initiatives the School has rolled out.

"We are not just training public servants. We are shaping digital leaders for a smarter and

KSG Completes e-GP Mapping, Setting New Benchmark in Public Procurement

he Kenya School of Government has successfully completed the comprehensive mapping exercise in the Electronic Government Procurement (e-GP) system, marking a major step in strengthening accountability and transparency in public procurement.

The exercise, which culminated went this week, beyond onboarding staff into the e-GP platform. It focused on aligning every procurement item with the **United Nations Standard Products** and Services Code (UNSPSC), a global classification framework that enables harmonization, minimizes duplication, streamlines procurement processes.

The mapping also covered people and plans. All KSG staff have been integrated into the platform to ensure ownership and accountability. The School's Annual Procurement Plan was

reformatted to fit the e-GP template, while each Campus uploaded its Departmental Plan. Together, these actions have produced a mapped procurement roadmap that balances national priorities with KSG's institutional needs.

Officials acknowledged that the mapping process requiring demanding, painstaking attention to detail cross-departmental collaboration. Staff grappled with some technical challenges and the complexity of locating precise UNSPSC codes. Despite this, the underscored has mapping as the backbone of a successful digital transition.

"Public institutions must walk the talk in adopting reforms. At the School, we adopted this mapping exercise not only as a regulatory requirement but as an opportunity to demonstrate our capacity to implement complex transitions," noted Mr. Mukhtar Mohamed who is the Deputy Director, Supply Chain at KSG. The successful mapping has positioned KSG as a role model for other state agencies adopting the e-GP system. With its dual role as a user and a trainer, the School is uniquely placed to share lessons and provide capacity building for the wider public service.

As Kenya intensifies financial governance reforms, mapping remains a critical first step in that procurement ensuring processes transparent, are globally efficient, and benchmarked. Completing this exercise marks the beginning of continuous engagement with the system, updates, and further capacity building for staff.

KSG has reaffirmed Government's vision under the Bottom-Up Economic Transformation Agenda (BETA), proving that accurate mapping of resources and processes essential to safeguarding public resources and supporting sustainable growth.

Is there a specific lawn area you're most proud of, and what's the story behind it?

Yes. My assigned zone- the Kipsunya Convention Area near the auditorium. I especially love the front area leading to the auditorium, it's the first view many visitors see, and I take pride in keeping it welcoming and immaculate. Every time I finish working on it, I step back to admire the result.

How does Baringo's climate influence how you care for the lawns?

Kabarnet, is fortunate to have steady rains through the year with less need for frequent watering. Still, I have to adjust my care routines depending on whether it's a wet or dry season. January and February are the toughest months with intense heat and dry
